TERMS AND CONDITIONS

- As an accepted registered member of the "Lochinvar Rovers Football Club Incorporated" (LRFC) you agree to accept and adopt all LRFC constitution rules, regulations & policies. LRFC committee decisions will be final and will take precedence.
- I accept full responsibility for MY/HIS/HER conduct and welfare whilst participating in any of the club's activities.
- **All Players FIRST AID/MEDICAL:** I give LRFC permission to administer basic first aid, which will include Band-Aids, Bandages, Soothing Creams and Antiseptic. In case of an emergency and a parent/guardian are not present or contactable, a LRFC member will call an ambulance and contact the emergency phone numbers provided on the enrolment within My Football Club. All relevant medical conditions need to be declared to LRFC Secretary along with the Coach and Manager to ensure awareness. An HVFA Injury Form must be filled out (can be obtained from the HVF Website) and submitted to the Club Secretary via email within 24 hours of the incident.

- **All Players:** LRFC Club Admin fee will increase by \$10.00 if not paid in full 5 (five) days prior to initial HVFA registration cut-off date unless prior written consent has been provided under the LRFC "Registration Part Payment Policy" (refer to document "LRFC.POL.009") which is available upon request - Strict conditions apply. Players who have not paid their registration fees by the first game will be deregistered.
- **All Players** – found guilty by the Competition Disciplinary Board are to repay any and all fines incurred to LRFC. All suspensions incurred will be adhered to without question. Any players, coaches, managers or committee members who fail to adhere to these decisions will receive disciplinary action including suspension or expulsion from LRFC.
- **All players,** parents, coaches, spectators and committee members must follow the applicable Code of Conduct available on our website and including the FFA National Code of Conduct along with local zones. Failure to follow may result in disciplinary action including suspension and expulsion from LRFC or legal action if deemed appropriate. My child and I are aware that we are not to engage in any negative talk about another player, team, coach, referee or LRFC club member and must not post any such comments on social media.
